Powerful contributions at the cutting edge of the media industry

Olswang advised BBC Worldwide on the 'Project Kangaroo' joint venture with Channel 4 and ITV, conceived as an industry-defining video-on-demand service. The sheer collaborative nature of this transaction looked set to redefine the market, changing the future of broadcasting. Kangaroo ultimately proved too much for the Competition Commission, which in early February blocked the project in its current form, though it may yet be modified.

Regardless, the outstanding Olswang team – headed by partner Selina Potter, together with corporate partners Paul Guite and Simon Morgan – took the lead on the licence arrangements between each of the Kangaroo partners and the venture itself. This required a detailed understanding of how each partner commissions programmes and acquires rights, its business as a broadcaster and the nascent market for video on demand. As such it exemplifies the firm's position at the cutting edge of the TMT sector.

This TMT forte was further illustrated through a range of major matters. The firm advised Satellite Information Services, the foremost supplier of television programming and data services to the UK and Irish betting industry, on the acquisition of the outside broadcasts division of BBC Resources. It also advised the London Organising Committee of the Olympic Games on various telecoms and technology projects, including acting on their single largest contract, the appointment of BT and Nortel as the key telecoms and technology providers for the London 2012 Olympic Games.

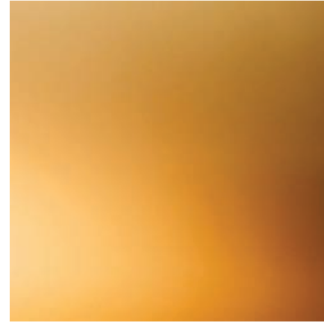
