A David v Goliath victory changing 100 years of patent law

This was a hard-fought battle through the UK courts that saw Wragge & Co defeat the odds. At the end of this high-profile, six-year fight with Virgin Atlantic Airways, Harris had not only saved his client, airline seat manufacturer Zodiac, £48m in fines and damages, but also played a crucial role in overturning 100 years of patent law.

The dispute centred on the Solar Eclipse flat-bed seat, which was created by Zodiac (then Contour). Back in 2007, Virgin Atlantic alleged that Zodiac infringed design rights and a European patent for flat-bed upper class aircraft seats.

Years of wrangling over the validity of the patent through the courts led Wragges and Zodiac to petition the Supreme Court to change the law in 2013. Following evidence presented during a two-day hearing, the Court did just that – a tremendous result for the client, which commented: 'The legal team has achieved this important result by being thorough and determined at every stage over many years and taking this case all the way to the highest court.'


