REMAINING AT THE TOP OF ITS GAME IN PORTUGAL

VdA has positioned itself well to lead the pack in a tough Portuguese legal market. Despite the pressure from local rivals and Iberian alliance firms, VdA's financials, credentials and geographical coverage means that the firm remains at the top of its game.

The numbers speak for themselves: in 2015/16 VdA managed 21% growth in both revenue and profit and has averaged 12% growth in turnover over the last five years.

The financial performance has been matched by significant expansion of the business, with the firm pushing its coverage to 11 jurisdictions including ramping up its presence in the Lusophone Africa countries Angola and Mozambique.

In a notable move, VdA hired a large team from a major local rival, increasing overall headcount by 10%. This has had tangible effects on the business, with the share of the international work in VdA's turnover going from 3% in 2015 to just under 20%.
