Pro bono on a global scale

Reed Smith Richards Butler is a firm that takes its corporate social responsibility extremely seriously. Indeed, far from being an afterthought, CSR is made central to the whole firm and is undertaken by a number of dedicated teams. The firm has a CSR committee, chaired by partner Michael Skrein, and includes the London managing partner, Reed Smith's worldwide chief strategy officer and representatives of the pro bono and community, green, and diversity and inclusion initiatives.

It is Reed Smith Richards Butler's pro bono manager Chris Marshall who wins particular recognition, however. He has played a central role in the newly established group Advocates for International Development (A4ID), chairing the board of trustees, managing the core team, and overseeing A4ID's trade practice. A4ID was launched by the Attorney General in October 2006 and is now a leader in the provision of international pro bono.

A4ID works with lawyers on a global basis. It connects members of the legal profession from a range of top-rated City law firms and their global offices, chambers and academic institutions to provide legal advice and assistance to developing countries and development NGOs. Reed Smith Richards Butler, and Chris Marshall in particular, play a key role alongside top City law firms, including most of the Magic Circle and leading US players. A4ID's headquarters is situated in the same offices as the firm at Beaufort House in London.

Clifford Chance's Cathy Jones has taken centre stage in ensuring that the firm lends a high degree of co-ordination, time and resources to capital punishment case work and international aid initiatives, as well as direct support to ten London boroughs. In addition, the firm undertakes far-reaching community, pro bono and environmental activities. It supports

well-deserved endorsement from Business in the Community (BITC)'s Community Index, an in-depth benchmarking management tool developed to challenge leading businesses and promote responsible business practice.

EVERSHEDS

Eversheds was the first law firm to publicly undertake BITC's Community Index, which allows firms to benchmark their community impacts. The firm has been praised by BITC for setting a precedent that other firms are now following. It is widely recognised as one of the best firms for career opportunities for women. Eversheds has also created a director of diversity, Caroline Wilson, with the express intention of increasing the number of minorities at the firm.

RUSSELL-COKE

John Gould

Putney-headquartered firm Russell-Cooke was a new entrant to the *Legal Business 100* in 2007. Despite the impressive rate at which the firm is increasing revenues, it has proved itself to be not entirely profits driven, and has backed this up by setting aside 10% of turnover for legal aid work. Nicola O'Connor, who works within the firm's criminal litigation department, has recently concluded a landmark case that has seen a murder conviction overturned. The firm also has the highest ratio of female partners (36%) of any firm in the *LB100*.
