### *Assured handling of Bar Council chair role*

Throughout 2013 McGowan QC impressed opponents and peers alike with her astute handling of the role of chair of the Bar Council during one of the most turbulent periods in the profession's history, where she championed the Bar's cause with an acutely pitched campaign.

During the year, she was faced with fundamental and emotive issues, such as wrangles over new standard contract terms at the start of the year before fighting the Ministry of Justice's controversial proposals to slice £220m off the £1.2bn annual criminal legal aid budget and proposing price competitive tendering (PCT). She was particularly emphatic on PCT, clearly stating: 'These proposals would move us from having a justice system which is admired all over the world, to a system where price trumps all'. After listening to the voices of discontent from practitioners, the MoJ scrapped plans for PCT in September.

Methodical and assured, McGowan will go down as one of the most effective and popular Bar Council presidents in recent memory.

The Supreme Court ruled that the Human Rights Act applies to soldiers wherever in the world they may be and refused to strike out any of the families' claims for breach of Article 2 of the act and for negligence.
